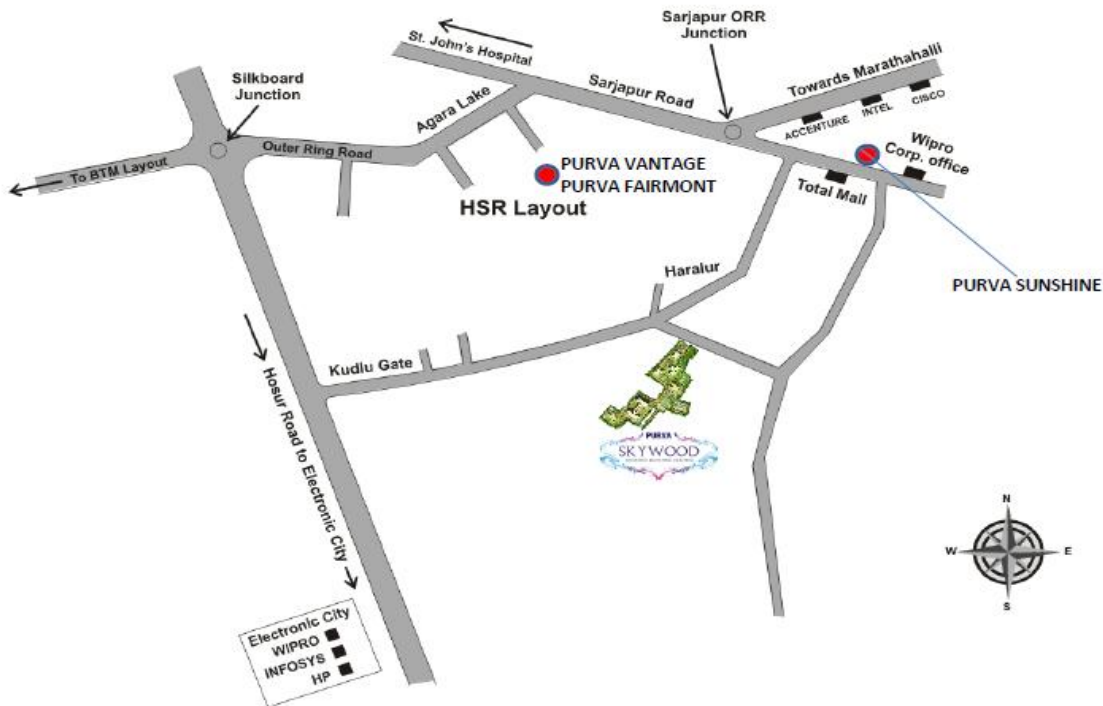

LOCATION MAP:



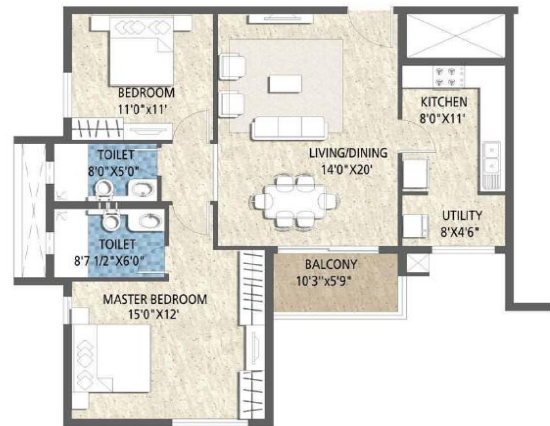
